Statement of Publishing/Confidentiality Agreement

This statement shall be a binding agreement between the Lambda 10 Project (no referred to as the Editors) and _____ (now referred to as the Writer).

1. Agreement of Publishing

The Writer confirms that he has voluntarily submitted text to the Editors for any and all purposes related to the consideration and publications for the Lambda 10 Project. The Writer acknowledges and agrees that the text submitted is the Writer's original creation and represents unpublished materials expressly written for the Editors' publications.

All names referred to by the Writer and included in the text have either been changed by the Writer for confidentiality purposes or the Writer shall have written authorization from these individuals whose real names appear within the manuscript. Any changes in names by the Writer also shall be noted by the Writer in submitting the text for consideration by the Editors. Writer also hereby confirms that the written material represents his own personal non-fiction account, and the events, situations, and details are portrayed in an accurate, truthful and complete manner.

The Writer agrees to grant the Editors all rights and permissions in reproduction and publication of the submitted material including any photos. Writer must complete separate Photo Permission form for Alyson Publications, Inc. if submitting any photographs for publication. The Writer may not submit or use the text for reproduction or publication, or as a reference material, in any other print/media, publications, electronic/technological publications, audio/audio visual publications, including educational and commercial television programs and movies until after the Lambda 10 Project publication has been published and released to the general public for purchase for 24 months. Writer also understands that his involvement in the Lambda 10 Project does not include any financial payments in exchange for manuscripts and/or sales resulting from publication.
